# PURPOSE OF MEETING

The purpose of the Annual Electors Meeting is prescribed within the *Local Government Act* (1995). The meeting is not to adopt the Annual Report but for electors to ask questions and to put forward any Motions which will be considered at the Council meeting on Thursday 22 April 2021.

In terms of voting on any Motion put before this meeting, those present will have already been asked to register on entry to the meeting. If any member of the public present isn't entitled to be an elector in the Shire of Murray, they will be asked to refrain from voting.

Councillors are also electors of the Shire of Murray and retain the right to vote for or against any motion. Should a member of the public wish to put a motion before the meeting the procedure that is used in Council meetings will apply, including the requirement to follow Council's meeting procedures during the debate on the motion. All motions put before the meeting will require a seconder before debate on the motion proceeds.

Any vote taken on any matter at the meeting is not binding on the Council but would be considered in light of all relevant information provided to Council in due course. The Minutes and any formal motions of this meeting will be presented to the Ordinary Council meeting on 22 April 2021 for consideration.
