Reason for Change: To clarify that the incumbent CBFCO shouldn't vote in an election to ensure incumbency doesn't have an advantage over other nominees, but that the CBFCO does vote on all other items at any BFAC meeting.

#### **In Brief**

To consider the proposed amendments to the Bush Fire Advisory Committee (BFAC) Terms of Reference.

#### **Background**

A recent review of the BFAC Terms of Reference was undertaken to ensure that the Terms of Reference were correct and reflect the requirements of the BFAC and Council.

The BFAC Terms of Reference were included as part of the Bush Fire Brigades Standard Operating Procedures Appendix Register which were accepted by the BFAC at its meeting held on 16 August 2023 and then endorsed by Council at its meeting held on 28 September 2023, (OCM23/131).

### Report Detail

A recent review of the BFAC Terms of Reference was undertaken to review the composition of the BFAC membership due to the changes in certain positions within the Shire together with the timelines for BFAC meetings, and the issuing of BFAC documentation. A copy of the reviewed BFAC Terms of Reference showing the proposed changes is provided at **Appendix 1**.

The major change is in relation to voting members. The view of the Chief Executive Office was that Shire of Murray officers should be advising the Bush Fire Advisory Committee (and in due course Council), and that they should not have a formal vote. This reflects their statutory and advisory roles.

Further, it is recommended that the BFAC and Council considers an alternative position to the current Standard Operating Procedure 8.2 where it states

#### 8.2 Nominations for BFCO and Permit Issuing Officers to the Shire

- (iii) the BFAC shall select (1) one of the nominated BFCO's for the position of CBFCD and select (1) one of the nominated BFCO's for the position of DCBFCO.

### Statutory Environment

Section 37 of the *Bush Fires Act 1954* deals with the establishment of committees and states:

#### 67. Advisory committees

(1) A local government may at any time appoint such persons as it thinks fit as a bush fire advisory committee for the purpose of advising the local government regarding all matters relating to the preventing, controlling and extinguishing of bush fires, the planning of the layout of fire-breaks in the district, prosecutions for breaches of this Act, the formation of bush fire brigades and the grouping thereof under group brigade officers, the ensuring of co-operation and co-ordination of bush fire brigades in their efforts and activities, and any other matter relating to bush fire control whether of the same kind as, or a different kind from, those specified in this subsection.

(2) A committee appointed under this section shall include a member of the council of the local government nominated by it for that purpose as a member of the committee, and the committee shall elect one of their number to be chairman thereof.

(3) *In respect to a committee so appointed, the local government shall fix the quorum for the transaction of business at meetings of the committee and may —*

*(a) make rules for the guidance of the committee; and*

*(b) accept the resignation in writing of, or remove, any member of the committee; and*

*(c) where for any reason a vacancy occurs in the office of a member of the committee, appoint a person to fill that vacancy.*

(4) *A committee appointed under this section —*

*(a) may from time to time meet and adjourn as the committee thinks fit;*

*(b) shall not transact business at a meeting unless the quorum fixed by the local government is present;*

*(c) is answerable to the local government and shall, as and when required by the local government, report fully on its activities.*

### In Brief

Amendments to clause 8 of the Bush Fire Brigade Standard Operating Procedures (SOP's) is requested to provide clarification to the procedures for the nomination and selection of Bush Fire Control Officers (FCO), Bush Fire Control Officers – Permit Issuing Only (FOCO-PIO), Chief Bush Fire Control Officer (CBFCO) and Deputy Chief Bush Fire Control Officer (DCBFCO).

### Background

A review was recently conducted of the SOP's and a recommendation is made for the amendment to clause 8 of the SOP's to provide a more open process be supported for the nomination, assessment and selection process for the positions of FCO's, FCO-PIO, CBFCO and DCBFCO.

### Report Detail

The SOP's were introduced in 2023 after significant consultation with Shire of Murray Volunteer Bushfire Brigades (brigades), FCO's, including the then CBFCO and DCBFCO. An extract of the current clause eight (8) of the SOP's is attached at **Appendix 1**.

Recently, the SOP's have been reviewed to ensure that they reflect current practices, and it is considered that clause 8 of the SOP that deals with the nominations and the selection process for the FCO's, FCO-PIO, CBFCO and the DCBFCO does not truly reflect the process that is actually undertaken, or the desire of Brigades. The proposed amended clause 8 is attached at **Appendix 2**.

The Shire of Murray Bush Fire Brigades Local Law provides the requirements for SOP's for the management and operation of the Shire's Volunteer Bushfire Brigades including the election of brigade office bearers including FCO's, CBFCO and DCBFCO, Captains, Lieutenants, Secretaries and Treasurers.

The appointment of FCO's, CBFCO and DCBFCO is dealt with in accordance with section 38 of the *Bush Fires Act 1954*, which states:

**38. Local government may appoint bush fire control officer**

*(1) A local government may from time to time appoint such persons as it thinks necessary to be its bush fire control officers under and for the purposes of this Act, and of those officers shall subject to section 38A(2) appoint 2 as the Chief Bush Fire Control Officer and the Deputy Chief Bush Fire Control Officer who shall be first and second in seniority of those officers, and subject thereto may determine the respective seniority of the other bush fire control officers appointed by it.*

## **Background**

In accordance with the Shire of Murray Bush Fire Brigades Local Law 2024 (local law) and the Shire of Murray Bush Fire Brigades Standard Operating Procedures (SOP's) the nomination for Bush Fire Control Officers (FCO) and Bush Fire Control Officer - Permit Issuing Only are determined by each brigade at their respective Annual General Meetings (AGM) and this then also supports the Shire's BFAC membership structure. A copy of the AGM minutes from the following brigades are attached at **Appendix 1**:

- Coolup VBFB
- Dwellingup VBFB
- North Dandalup VBFB
- West Murray VBFB

The AGM for the South Yunderup/Ravenswood VBFB will be held on the 19 May 2025 and therefore a copy of these AGM minutes were not available to be distributed with the agenda.

With the introduction of delegated authority in recent years, the appointment by Council of FCO's, Chief Bush Fire Control Officer, Deputy Chief Bush Fire Control Officer, Fire Weather Officer and Deputy Fire Weather Officer is no longer required as the CEO has the delegated authority under *Section 48* of the Act to make these appointments. Additionally, the appointment of Fire Weather Officer/s also requires DFES endorsement.

However, the CEO continues to support the democratic process that currently exists.

## **Report Detail**

The proposal and recommendation presented to BFAC is to support the appointment of the nominated FCO's, including FCO's - Permit Issuing Only as nominated each of the brigades.

In consideration of the importance of both the key roles of Chief Bush Fire Control Officer and the Deputy Chief Bush Fire Control Officer and ensuring that any brigade members nominating for either position is compliant with criteria as outlined in the Position Description for each of the roles as established under the SOP's, an Expression of Interest (EOI) process was undertaken and circulated on the 13 April 2025 to all brigade captains, brigade secretaries and the current CBFCO, DCBFCO's and FCO's with a closing date and time of 5pm Friday 9<sup>th</sup> May 2024.

The following three (3) EOI submissions were received for the CBFCO role and three (3) EOI submissions were received for the DCBFCO role prior to the abovementioned closing date and time:

The Director of Corporate Services and the Manager Ranger and Community Safety undertook a review of the Eol submissions, and it was considered that the submissions for the CBFCO role and the DCBFCO role satisfied the criteria as described in the Position Description in the SOP's.

This was to ensure that Shire had a record of each brigade's AGM minutes and also a copy of each brigade's respective nominations for FCO's. PCO's – Permit Issuing Only, Fire Weather Officer, Deputy Fire Weather Officer and Shire Training Coordinator.

To determine the Shire of Murray 2025/2026 Bushfire Compliance Notice (Notice) to manage bushfire related matters within the district in accordance with Section 33 of the *Bush Fires Act 1954*.

**Background**

The Shire of Murray Firebreak Notice was previously reviewed and amended in 2023 in compliance with the WALGA and DFES developed Guidance Notes that were provided to support Local Governments to produce a standard, clear, concise and enforceable Notice that aligns with regulatory requirements.

Further minor amendments of the 2025/2026 Notice have been again undertaken to include the feedback received from Bush Fire Brigades and Bush Fire Control Officers about the 2024/2025 Bushfire Compliance Notice to include:

- the provision for the burning of garden refuse and rubbish,
- the provisions for camp and cooking fires,
- provide clarification of the requirements for land over 45,000m<sup>2</sup>; and,
- provide further clarification regarding any items that require the burning of any solid fuel during the restricted and prohibited burning time, including the use of fire pits, chimineas, pizza ovens, solid fuel BBQ's that require the burning of wood, charcoal or heat beads.

## Report Detail

As stated, the Notice is developed in accordance with section 33 of the Act and is designed to provide important information about bushfire preparedness and prevention, bushfire risk mitigation plus sufficient means to direct landowners to undertake works to prevent the outbreak, spread or extension of a bushfire. The Notice also provides a mechanism for Special Work Orders to be issued to landowners to further reduce bushfire hazards, if required.

The proposed Notice will also be specifically formatted to be published within the *Government Gazette* and also within the local newspaper. All information contained in the Notice will also be advertised on the Shire's website and periodically various subjects and information from the Notice will be advertised on the Shire's social media site to bring to the attention of land owners/occupiers' important information during the bushfire season.

Section 33 of the Act provides local government with the legislative authority to make a Notice requiring all owners or occupiers of land within the district to undertake work on their land for preventing the outbreak of a bushfire, or for preventing the spread or extension of a bushfire which may occur.

Section 24G(2) of the *Bush Fires Act 1954* provides a local government the ability, by notice published in the Gazette and a newspaper circulating in its district, to prohibit or impose restrictions on the burning of garden refuse within its district that is otherwise permitted under section 24F of the Act.

Section 25(1)(1a) of the Act provides a local government the ability, by notice published in the Gazette and a newspaper circulated in its district, to prohibit or prohibit the lighting of fires in the open air in its district for the purpose of camping or cooking for such period during the prohibited burning times as is specified in the notice.

#### In Brief

Dear Members,

This year presented us with a milder season than we are typically accustomed to. While I'd like to credit this to a well-educated community, I believe luck also played a part—especially given the high threat levels we experienced. That said, we have witnessed a few escaped burns during the restricted period.

In response to prevailing weather conditions, we extended the Prohibited Burning Period by four weeks and the Restricted Burning Period by an additional two weeks. Unfortunately, conditions have not yet been favourable enough to move into the Unrestricted Period.

Our brigades responded to a total of 179 incidents this season. The table below compares the previous 2 years of incident but does not include any incidents from May 6<sup>th</sup>. Many of these saw multiple Incident Controllers throughout with incidents managed by the Deputies, Captains, FCOs, Lieutenants, brigade members and I was able to attend several incidents to provide help, support and mentoring to those that I have mentioned above who were managing the incident and not actually taking over the incidents as Chief. This highlights the dedication, calibre and depth of leadership within our brigades. I'd like to commend all brigade leaders and members who stepped up to take on the command roles and who actively mentored others taking on responsibilities as Incident Controllers, Crew Leaders, Ground Controllers and Sector Commanders.

The 12.2 appliance saw extensive use across the region. On only a few occasions were we unable to crew the 12.2— an very impressive outcome. A special thank you to the Coolup Brigade for consistently providing crews throughout the year.

We also had a High Season Light Tanker stationed at North Dandalup for a few weeks before it was relocated to West Murray for the majority of the fire season. Thanks to both brigades for supporting the deployment of this resource, which also responded to incidents in the northern regions. Thank you to DFES for providing that additional appliance during our fire season.

This year we welcomed two new appliances: the North Dandalup Light Tanker and the Dwellingup 1.4. Additionally, we have submitted an application to the LGGS for consideration of an additional Light Tanker for the Dwellingup Brigade, with an update expected by June.

We held four leadership meetings throughout the year. These sessions provided valuable opportunities for open discussion and collaboration on matters affecting our brigades. Our brigade SOPs are being reviewed again by the brigades to then be brought back to our leadership meeting in June 2025. The SOPs will continue to be a working document with all changes endorsed by council.

Training participation remains strong, with 43 members attending courses both within and outside the Shire. This continued commitment to upskilling not only strengthens our brigades' capabilities but also builds confidence among volunteers as they step into their various roles.

I want to personally thank each of you for the incredible support I've received over the past 12 months as Chief. Your open communication, trust, and willingness to back each other—and me - it has meant a great deal.

To the Deputies:

**Peter**, as this season marks your final one in the role of Deputy, I want to extend my heartfelt thanks for your guidance, support, and conversations. While we may not have always agreed, our differing views often led to stronger, well-rounded solutions. I know your mentorship will continue to be invaluable from within the brigades as we pursue our shared goals around growth, personal development and succession planning.

**Jussy**, you've shown real strength and determination in stepping into the newly appointed role of Deputy South. Your commitment has been both clear and commendable. You've faced challenges—some no doubt not listed in any position description—but you've sought advice when needed and stood confidently by your decisions. That kind of leadership makes a real difference.

**DFES**, thank you for the continued support you provide to our brigades and the Shire in times of need. It's truly appreciated to know we can rely on your assistance when it matters most.

And last but certainly not least, to the **Shire of Murray and Councillors**—thank you for believing in me and trusting that my decisions are made with the best interests of both the brigades and the Shire at heart. Your support has been invaluable.

To those stepping into newly appointed positions within the brigades—I wish you all the very best. You are in safe hands, with great mentors not only within your own brigades but also across our broader network. Lean on each other and keep growing together.

## 6.2 Manager Ranger and Community Safety

### In Brief

The following summary is provided as the major activities for Emergency and Bushfire Management.

- The Shire's Local Emergency Management Arrangements (LEMA) including the Local Recovery Plan and Welfare Plans have been completed and endorsed by the Shire's Local Emergency Management Committee at its meeting on the 2 April 2025 and the item will be considered by Council at its meeting on the 22<sup>nd</sup> May 2025.

The review of the LEMA and other plans was conducted due to the separation of the joint Shire of Murray and Shire of Waroona LEMC with the updating of all LEMC details together with the updating of all contact details for various other agencies, organisations and suppliers of goods or services.

The full review of the LEMA is due in 2027.

- A review has also been completed on the Shire's Bushfire Management and Response Plan which will be circulated to the CBFCO, DBFCO's, FCO's and brigades so that they can go through draft plan and provide feedback.
- A Bushfire Risk Mitigation Plan has been developed for Yunderup, Ballee and Cooleenup Islands. The mitigation plan has been developed in consultation and liaison with the residents of the islands, Dean McGuinness, Captain of the South Yunderup Ravenswood BFB, CBFCO and the Shire's Bushfire Risk Mitigation Officer. A funding application for the mitigation works has recently (April) been submitted to the DFES Mitigation Activity Fund and we are awaiting the outcome of the Shire's funding submission, which should be advised by June 2025.
- You are most probably aware that a recent restructure of the Shire's Ranger and Community Safety department, resulted in the contract for the Community Emergency Services Coordinator for Nicole Stevens not being renewed with DFES by the Shire. Instead, Nicole Stevens has been employed on a full-time basis as the Coordinator Rangers and Community Safety (CRCS), which will continue to coordinate and support all brigades, and the Murray SES as previously provided with the only change being that the day-to-day operations of the Shire Rangers will be managed by the CRCS position. I take the opportunity to congratulate Nicole Stevens on her successful appointment to the role, which I know she will do an outstanding job and has already.
- Also, due to the restructure of the Shire's Ranger and Community Safety department, the Shire advertised for a Bush Fire Risk Mitigation Officer (BRMO), which closed on the 30 April 2025. Several excellent applications were received and the recruitment and selection process is continuing, which should see the appointment of someone into the role in June 2025. There are several key responsibilities of the role including the review and updating of the Shire's Bushfire Risk Mitigation Plan, updating of the DFES Bushfire Risk Mitigation System, programming of bushfire mitigation works on shire owned and managed land, working with brigades in the development of prescribed burning plans and assisting and providing information about bushfire risk mitigation to State agencies, land developers and private landowners.
- In consultation and liaison with DFES, the Shire is currently conducting a review of Bush Fire Brigade buildings (fire stations) and future resource requirement for the Shire. Currently, the 2 brigades identified for new fire stations are South Yunderup Ravenswood BFB and West Murray BFB. North Dandalup has also been identified as requiring extensions to their existing fire

appliance bays with the extensions to include office/s, communications room, training room, male/female change rooms/toilets/showers and offices.

Currently DFES is in the process of determining their future service provision for both Career and Volunteer Fire & Rescue Services. The Shire is in the process of identifying potential locations for new fire stations should it be considered that new fire station locations may be required due to the current and future development of residential, commercial and industrial areas, together with the assessment of risks within each of the areas and the district as a whole.

- The Shire recently signed a new MoU with DFES for the provision of the 12.2 appliance. There were no changes with the MoU, however, there have been recent robust discussions about out of district deployment of the 12.2, the Shire of Murray requirements, especially during the High Threat Period being first the consideration prior to any deployment of the 12.2 or any other appliances out of district.

In closing, I would like to thank shire staff, all bushfire personal, brigade leaders, office bearers and all volunteers for the enormous amount of time, work and effort that is provided 24 hours a day, 7 days a week to safeguard the Shire of Murray and other communities. Our community and communities across WA would be unable to cope with any emergency if it weren't for the dedication and commitment of our emergency service volunteers.

I would also like to thank all the brigade officers and office bearers, Nicole as Chief, Peter Thurkle and Justyn Bennett as Deputy Chief's for their enormous efforts and contribution and I look forward to working with the new teams.

I would like to acknowledge the significant contribution provided by two stalwarts of the shire and the bushfire fraternity in Peter Thurkle and Jim Camplin who have both provided decades of service, dedication, training and mentoring to brigades, shire staff and volunteers across several shires in various brigade and shire officer positions. I am informed that they will still remain within the brigade ranks and that is very heartening to hear because there will still be many a volunteer that will be able to benefit from both Peter and Jim's immense knowledge and experience. I personally have known Peter and Jim for decades and I personally thank them for all they have done, their war stories and some very funny stories over the years and wish them both the very best for their future endeavours.

##### **Fire Season 24/25**

Conditions are starting to ease with the SDI still sitting around 1650 In Dwellingup, 1700 in Harvey and 1500 in Collie. This has been evident with the increase in lost prescribed burn on private property across the Southwest district.

#### **Brigade training Nights**

I would like to congratulate all the Shire brigades on the work to facilitate brigade level training. The uptake of training has been well received and as always, I am happy to attend brigade training nights to support and assist as required.

#### **High Season Fleet**

The Shire of Murray had a high season fleet LT and have crewed this when required this fire season supporting fires within and outside the Shire of Murray. This work from Shire of Murray crews has been extensive and extremely appreciated by the Department and surrounding LGA.

DFES SW have managed to keep 2x LT and 1 x 2.4 for mitigation fleet. Should the Shire require them to assist in completing prescribed burns, please reach out.

#### **Lessons from recent burn over**

This fire season has seen an unfortunate accident involving a burn over in a local Shire and fortunately the crew had minor injuries due to the training and actions of the crew. Its import we always conduct burn over training preseason and ensure we capture the small detail items to prevent serious injury including

- Don PPE before turning out
- Ensure the vehicle windows and doors are closed
- Always conduct LACES
- Check communications before entering fire ground
- Always have a safe zone identified and communicated
