5.1.3 Exercise

The Murray River Flood Exercise was held on 8 May 2025. This was organised and coordinated by DFES. It was a functional level 2 exercise that was based on a 1:100-year flood scenario which resulted in major parts of the Shire of Murray being flooded including Pinjarra.

The exercise was well organised and involved a multi-agency response with the activation of the MALC as an evacuation centre. The Shire's staff establishing and coordinating the Evacuation Centre at the MALC performed extremely well in the exercise with assistance from Department of Communities.

A post exercise report hasn't been received from DFES yet, however for the Shire of Murray there were lessons learnt from the exercise including alternate sites for the Shire Administration office, animal welfare and the establishment of recovery management. For the MALC team, improvements identified were having standalone translation/language cards, a FAQ sheet and list of pharmacies that were able to process prescriptions.

It also provided a mentoring opportunity for DFES and Shire staff. Thank you to DFES District Officer Emergency Management - Brian Penman for organising and allowing other agencies and the Shire to be involved.

5.1.4 Review Local Emergency Management Arrangements

The LEMA and sub plans were adopted at the last LEMC meeting on 2 April 2025 as per LEMC recommendation LEMC25/003 and at the Ordinary Council Meeting on 22 May 2025 as per Council Decision OCM25/052. This was a minor review to split the documents due to the joint LEMC and Resource Sharing contract with Shire of Waroona ceasing.

The Shire will be applying for AWARE funding to conduct a complete comprehensive review with the project having to commence prior to March 2026 and be completed within 12 months. The review will include comprehensive community and stakeholder consultation and a review of the Shire's Emergency Risk Register.
