

Building Permit Application

Fees and Charges

The fees for any application shown below must be paid upon submission

Estimated value of building work as determined by the local authority.

Most fees are based on the value of the building work. To ensure the fees are paid equally for all builders (including owner-builders) the Building Regulations 2012 has specified that the sum of all relevant components add up to the estimated value of the building work. The relevant components are:

- a. All goods (including manufactured goods forming part of the work); and
- b. Labour; and
- c. Services necessary; and
- d. Fees payable;
- e. Overheads to be met; and
- f. Profit margin.

Building Permit Application Fee

Building fees are set by the Building Regulations 2012 and are calculated as a percentage of the contract value or estimated value (including the GST) of the building work.

Building Services Levy

The Building Act 2011 requires a levy to be collected by the Shire for the Building Commission.

This levy is collected to fund the operations of the Building Commission to regulate the building services industry.

Construction Training Fund Levy (CTF)

A Construction Training Levy is required for all construction works in WA and is 0.2% of the estimated value of construction work above \$20,000 (including GST).

The levy applies to:

- Buildings (residential, commercial, industrial, resources sector)
- Non-buildings (civil, engineering, groundworks, fences)

The levy is to be paid direct to the CTF. Please go to this site to pay <https://ctf.wa.gov.au/levy>. A receipt for payment of this levy is to be supplied when making an application for a building permit.

Swimming Pool/Spa Barrier Inspection Fee

A barrier inspection fee of \$260.00 is applied to all applications for a swimming pool/spa. A mandatory inspection of the barrier is to be carried out by the Shire within 30 days of completion of the swimming pool/spa.
