

Community Sponsorship Fund

Application Form

The Shire recognises and supports residents selected to take part in sporting, recreational or academic events at a state, national or international level.

Eligible applicants can receive \$200 towards event costs. The event must be outside a 200 km radius of the Shire Administration Office.

The fund opens twice each financial year. Complete applications are considered in the order received. A round may close early when all available funding has been allocated.

Payment is made after the event, once a short follow-up form called an acquittal has been submitted.

1. Who can apply?

If the applicant is under 18, a parent or legal guardian must complete and sign this form for them.

Applicants must meet **all** the requirements below. Please check each box.

The applicant lives in the Shire of Murray

The applicant has been chosen to take part in a sporting, recreational or academic event at a state, national or international level.

The event is outside a 200 km radius of the Shire Administration Office at 1915 Pinjarra Road, Pinjarra.
